
DaiLY — Terms & Conditions

1. Acceptance of Terms

By creating an account and using DaiLY ("the App"), you agree to be bound by these Terms and Conditions ("Terms"). If you do not agree to these Terms, you must not use the App and should exit immediately.

2. Description of Service

DaiLY is a personal productivity and task management application designed to help users organise, prioritise, and track their tasks and responsibilities. The App may include automated features, such as the Priority Assistant, which provide suggestions only and are not a substitute for professional judgment.

3. User Responsibilities

You are solely responsible for the accuracy and completeness of any information you enter into the App. You agree to use the App only for lawful purposes and in accordance with these Terms. You must not use the App in any way that could damage, disable, or impair the App or interfere with any other party's use of the App.

4. Automated Features — Limitation of Liability

Certain features of the App, including but not limited to the Priority Assistant, use algorithmic models to generate suggestions. These suggestions:

12. Eligibility and Minimum Age

DaiLY is intended only for individuals who are at least 16 years old. By creating an account, accepting these Terms, and confirming the age certification, you represent and warrant that you are 16 years of age or older. If you are under 16, you must not use the App. If we become aware that a user is under 16, we may suspend the account and delete the associated data.
